

General Information:

- 1.1 Due to the limited number of booths, the organization (Hong Kong Football Club) will make selections with reference to the type, style, and categories of the vendor's products.
- 1.2 The organization has the final decision to select vendor without any explanation.
- 1.3 The organization may use the brand icon / logo and product photo(s) posted in social media by successful vendor for the purpose of market promotion without any notice.
- 1.4 The information collected is only used for the preparation and promotion of the event and will not be transferred to third parties without the consent of the vendor.
- 1.5 If the vendor decides to withdraw from the event due to personal or other reasons beyond the control of the HKFC, all paid fees will not be refunded and the vacant booth will be transfer to another new vendor.
- 1.6 If the event cancels or changes the original location due to any special circumstances such as weather, venue problems or other force majeure factors, the organization will not refund the relevant application fee and will not compensate the successful application any lost.
- 1.7 [About COVID-19] If the Club needs to be closed / the event cannot be held due to the impact of the pneumonia epidemic (including but not limited to the government's epidemic prevention policy), the event will also be cancelled / postponed. In this case, the organization will arrange for vendor who are successfully selected and have paid the application fee to choose to renew their participation in the event (if there is an extension) or refund the full rent; However, if the venue is not closed, the event must be held as usual in accordance with the terms of the contract. If the vendor decides not to attend the market due to personal reasons (including but not limited to failing to comply with the government's anti-epidemic policy, etc.), the organization will not refund the paid fees.
- 1.8 Successful vendor must pay all the fees before the specified date and time (exact date and time to be announced after the deadline of application), otherwise, they will be deemed to have waived their eligibility to participate in the event, and the organization will arrange for subsequent vendor to replace them without prior notice.



- 1.9 Joint vendors are not allowed. Each booth rental is limited to one vendor only. However, every vendor can rent up to 4 booths at one time.

****** After the application result is announced, successful vendor is not allowed to increase / decrease the number of booths rented for the event. ******


- 1.10 After the announcement of the application results, any successful vendor shall not transfer their booth to other vendors / companies.
- 1.11 Successful vendor will receive an email notification on the email provided.

About the Booth:

- 2.1 The size of the booth table in this event is 6 feet (1.8m) x 2 feet (0.6m), the height of the table is about 75cm, 2 chairs will also be provided.
- 2.2 Successful vendor can arrange their own decorations to set up their booths, and all items can only be used within the designated booths.
- 2.3 The organization will pre-arrange the booth positions of the successful vendor. Successful vendor cannot object. The organization will reserve the final decision to change the positions of all booths.
- 2.4 Pets are not allowed in the venue (except for guided dogs).

About the Government's "Vaccine Bubble" Arrangement:

- 3.1 As per the Government's announcement, from 24th February 2022, all people entering restricted premises (Hong Kong Football Club are also relevant premises) must use the mobile app "Leave Home Safe" and must meet the requirements of the "Vaccine Pass".
- 3.2 All person entering the premises must comply with the relevant regulations of the "Vaccine Bubble".
- 3.3 Please be reminded that relevant law enforcement officers may be present to conduct random checks to all participants (no matter staffs or visitors). If the participants fail to comply with the relevant regulations, the law enforcement officers may issue penalties to the relevant persons.



Responsibilities of Vendors:

- 4.1 The products and goods / services sold by the vendor at the booth must be the same as those filled in the application form. The applicant shall be responsible for any investigation caused by any fraud cases.
- 4.2 Regardless of whether the application is made individually or jointly, each applicant can only submit one application form and cannot be repeated, otherwise the application will be disqualified.
- 4.3 Vendors for food stalls must comply with the relevant health regulations and must apply for a food license or temporary food license or other relevant licenses by themselves. All risk or legal issues related to food will be the responsibility of the vendors, and the organization will not take any responsibility. Applications for cooked food stalls that are cooked on the spot with an open flame will not be accepted.
- 4.4 The organization will not be responsible for the safety of vendors, and the organization will not be responsible for any harm or damage to vendors in the event.
- 4.5 Successful vendor shall not cause any danger, injury or nuisance to anyone in the event (including but not limited to burnt incense sticks or any similar items), and the organization will not be held responsible for any casualties. Any responsibility, the vendor shall bear all responsibilities and compensation.
- 4.6 In case of any disputes, the organization has the final decision.
